Dear Mr. Marc A. Giroux,

Sally A. Gomery has been placed on Notice of Civil and Criminal Liability for abdication of her Oath of Office, fraud and perjury on the Court of Record, and making determinations in her private capacity not sanctioned by the Court, and for accepting private pleadings from the city of Ottawa in violation of the Rules. Your own letter to Me states that Judges are responsible for ensuring the Rules of the Court are followed, while the justice accepts private pleadings outside of the Court process and in violation of the Rules.
