Good afternoon,

I am Writing You in regards to a short story that was Writ for an O.A.C (Ontario Academic Credit) English course taught by a teacher of Your school known as Ms. Cadman roughly 27 years ago, in the 1994/95 school year.

I am sensitive to the fact that this was a very long time ago and it is unlikely these records (and the story in particular) are still on the school premises. I am hoping You can direct this email and My query to the appropriate records office for such educational archives.

I am also going to provide some background to My query because the reason I do not have the short story I am as King of You to help Me recover is because it involved an incident between the author of the story and Ms. Cadman that was ultimately responsible for the author terminating his studies with K.C.I one credit short of his high school diploma. Your records Will show the author of the story in question had 29 credits at the time he dropped out, and that he did so only one week into a new semester where he had only signed up for a single OAC English course with Ms. Cadman.

I Writ a short story for the year's first English assignment to explain a cliché, I chose from a list of several options, 'Like a Fish Out of Water'.

The reason I am providing You with this prequel is because I was the only student in the class to not have the paper returned to Me. When I was as King of Ms. Cadman why My paper had not been returned to Me, she said she was not returning My paper because she believed it to be a forgery. It's as ridiculous and false a statement now as it was that day, and though Ms. Cadman could not cite any example or provide any particular reference, she conceded that she does not need any *proof*, she Will need to see more of My Writing first. I advised her that she was in breach of contract as a teacher Trusted with My work for a specific purpose, and that if she failed to apologize, grade the paper and return it to Me, she was guilty of theft of My intellectual, private property, breach of Trust, and defamation of character.
