Dear Noah and Laraine,

You have been advised that You (Noah S. Potechin and Laraine Burton) have NO FURTHER INTEREST in this Matter. King Sean, House von Dehn, Hand of Stephen, Kingdom of God is the eldest son and rightful heir to the Estate of Joachim Heinrick von Dehn **in any** Common Law Court where the **Rule of Law** is Honoured.

You are threatening further economic harm to the Estate for its intended beneficiaries by compelling Us **under duress and without prejudice** to make an application to the Court when We have **all agreed to the equal disbursement of the remainder funds!!!** You are Creating conflict where there is none, contrary to Your duties and obligation to Act in the best interest of the intended beneficiaries.
