## Writ of Mandamus

I hope and Trust You have had a fabulous Holy Day season.  
I am in very Good spirits because I was celebrating the fifth  
year since I officially placed My Trust in God - for Me, it was  
the fifth year anniversary of God's Kingdom on Earth.

I am writing in reply to Your letter dated October 26<sup>th</sup>  
2021, and although You have indicated that the letter was  
sent in error, and that I should disregard, it is evident a  
reply is required, as the letter was addressed to 'Dean VonDehn'  
and I'm not sure who or what that is, but I presume that  
You are addressing Me, the Man more commonly known as  
Dean (vonDehn).

So I spend the better Part of Christ-mass day further  
defining My Trust for Your benefit. My Trust in God should  
be of Benefit to every One, not just Me.

I also apologize if it seems condescending in its expression, but it is intended that the Declaration of Trust should be easy enough for a child to comprehend in the event of My death. Most children don't need to be told that a Man's Life has Value, or that the Man is the Author of Wit of his Life and wealth. To a child, these truths are self evident - the state can't discern between a Living Man and an artificial person. The Man has Real needs to maintain his Real Estate, the artificial person is an account created for the Man's benefit.

You were as King of Me to:

- Consent to disclose and verify personal information
- Consent to disclose information - Revenue Canada Agency

We need to be very clear that the only "person" Canada knows is a Living Man who goes by King Dean to distinguish him from the artificial person, Dean von Behm. However, King Dean was given the name Dean Stephen von Behm, and that title has since been placed in Trust. King Dean was also trusted with the Body he was given by God who also made King Dean Head of his Nation State and Capital. God has trusted Dean to take

Good care of His Kingdom. God appointed Me King over My Body of People, I did not choose it but to accept what was already trusted to My care. I am the trustee of God's Real Estate and Holder of His property. It is God's Intent-ion that the King's wealth should Reign down on all of Man's kind, and wash the world of its debt (SIN).

You do have My conditional acceptance to verify personal information with every single office and agency within Canada's government for the purpose of conducting a full forensic audit of dean (stephen) vonDohn's Estate. This forensic audit should include all records of all funds borrowed for social protections and government services, as well as all Real property assets such as (but by no means limited) school records, dental and medical records, and most importantly, a final bill from Revenue Canada for a full account of all funds borrowed by Canada in My name. A bill for My share of the S.I.N. account is also required.

I am as King of You for a forensic audit in hopes of demonstrating the quantity of My Life's work that remains in Your Trust. All of that inform-a-dean, any document with My name on it, is a "His story" call (name) Act-I-Fact of My House and Kingdom. You are holding all of that property which infers a Trust relay-dean-ship. All state actors in any capacity are trustees of this Public Trust. My Life has Great Value and I am trusted with the administrate dean of that wealth.

You were as King of Me to apply for a birth certificate, social insurance number, and Health card. The reason You are as King is because You require My consent. You wish for Me to Trust You to provide for My health care. The second I apply, I approve Your request and You Issue a Bond to a bank who deposits into an account and loans You money to not fulfill Your obligation to Me or partially fulfill according to some Act of parliament (like Ontario Works).

The amount of the bond would be at least a million dollars, probably several. I may or may not ever require it, so it makes more sense for Me to pay on Demand, as Goods or services are necessary. As Trustee and Executor of the Trust God has placed in Me, I can Issue Bonds and Certificates, disposing of Real Estate time shares with a thumb-print deposit. Everything I touch will turn to Gold. How much do You think these documents are worth? This is His-story in the making, and it's a Good read.

You are not providing for My needs, so I have placed My Trust in God. You are issuing credit to an account, You are not Giving Me anything of Real Value. You are compelling Me to Give People promises to pay instead of wealth. When will You fulfill Your promises to pay, and why should I suffer for Your negligence? How do You justify paying Trustees more than the Beneficiaries in need? You don't - it's fraud.



You may or may not succeed in providing a full forensic accounting for the insured person's commercial value in debt, but I do wish at the very least to make Good on the Honour of My word as I go. Everything I purchase is a Promise to Give something of Real Value later. So I am going to Honour that Promise by accepting (buying) those receipts at face Value by depositing a share of My land equal in Value to My time and interest. The receipts I'm sending You are worth their dollar Value, and You will issue credit to the Beneficiary's account equal to the amount of the receipt.

I am employed as the trustee of Your beneficiary and I am entitled to receive a living wage for handling the day to day duties of the trust. If You were fulfilling Your obligations, this Letter would not be necessary. I am not charging You for My precious time this time, though I cannot Trust You with any more Original documents as they are far too Valuable. Don't lose any of those Valuable receipts, though!

## Business and Trust Expenses

My wealth is Good for every One. The Trust has expenses and My Life is worth investing in. Office expenses, utilities, Living expenses and maintenance costs to keep the King's ship in Good repair. The Beneficiary should be entitled to at least the comfort of Living enjoyed by the Trustee, so I am thinking that the Beneficiary should receive monthly payments equal to that of the entry level wage of an Ontario Works agent, operating on the presumption they will not <sup>take</sup> more than necessary in the best interest of the Public Trust. 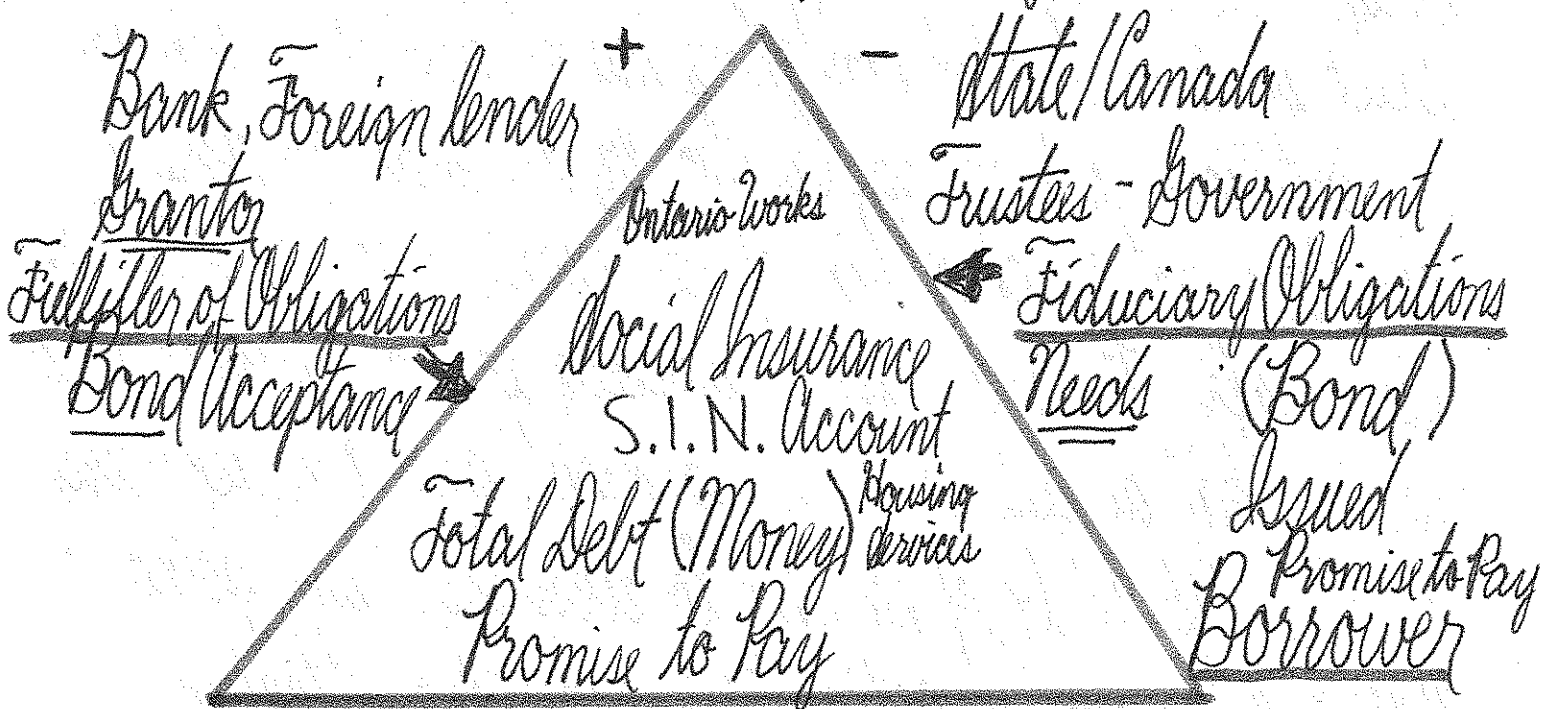

# Consent to Disclose and Verify Personal Information for Canada Revenue Agency

To: Fatima Lindstrom for the Ontario Works Administrator:

Declaration of Trust

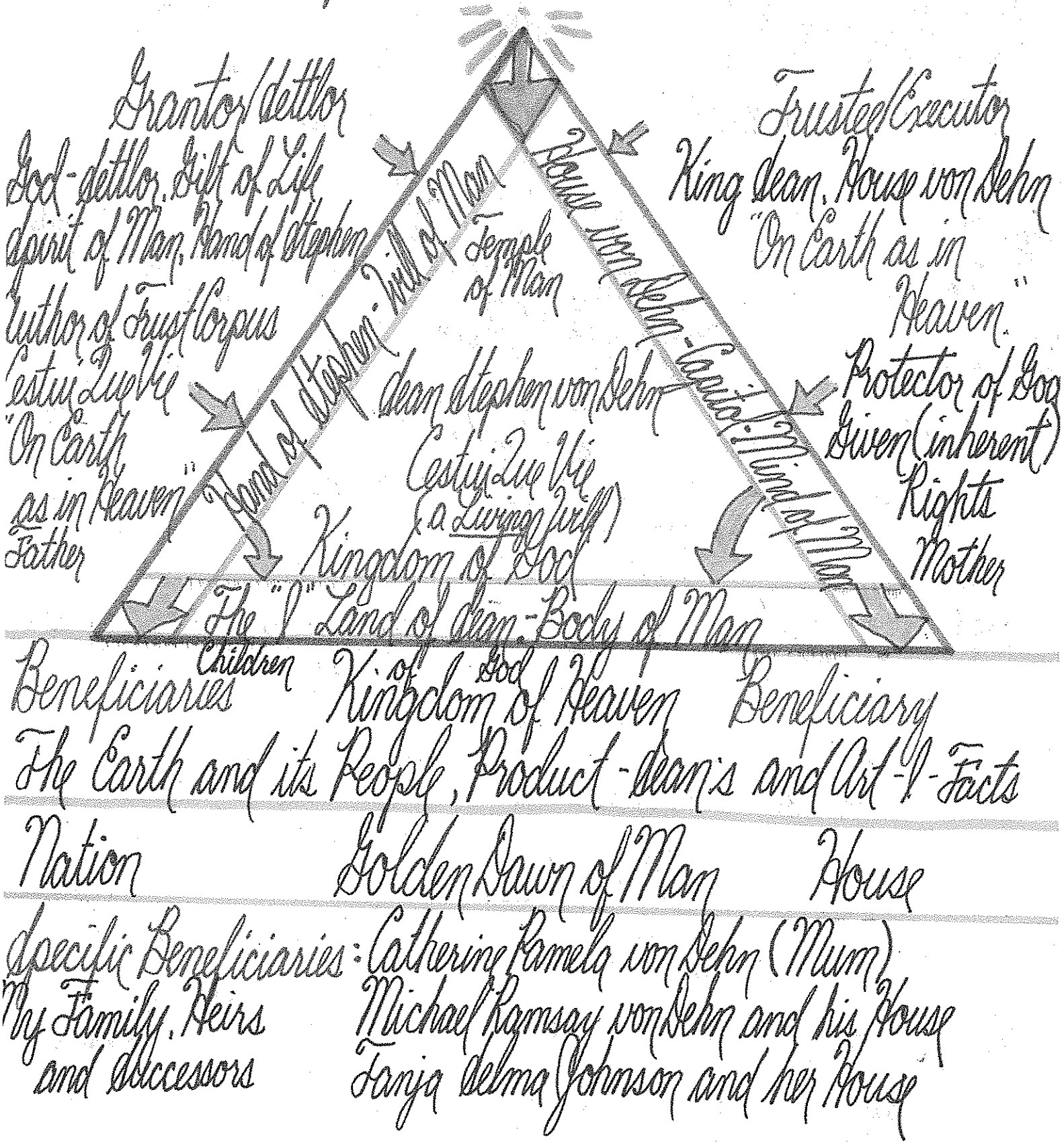

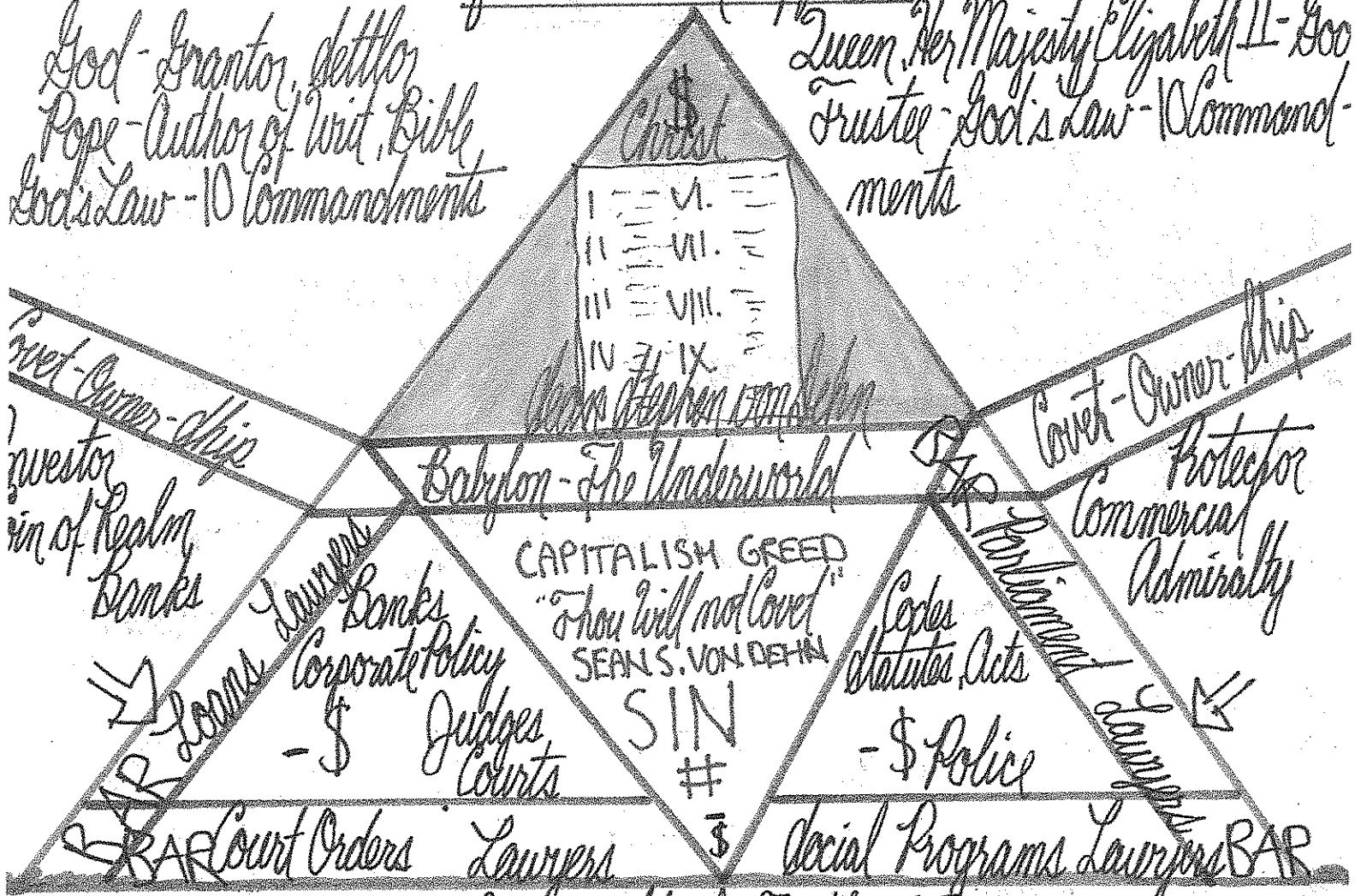
