To Lili Mukalay, Krystal Skof, Tatiana Lindstrom,

You have until 5:00 PM tomorrow (Friday, August 19th, 2022) to respond to the Notice of Criminal and Civil Liability for Breach of Trust with Criminal Intent that was legally and lawfully served upon You, Friday, August 12th, 2022. You were clearly advised that 'Default Judgment, Nihil Dicit, Res Judicata' Will be awarded against You if You fail to respond.

You are required to produce the following before 5:00 PM tomorrow:

1. A copy of the Renewal Package that was returned to MHI for My Records
2. Compensation for Breaching Colleen Lynch's Trust by sharing a private document from her file with multiple third parties
3. Compensation for Breaching Sean von Dehn's Trust, and for harassing him to destroy his documents to aid and abet Your Breach against Colleen Lynch and destroy the evidence, attempting to coerce and intimidate him into committing a criminal offense
4. A copy of Your Oath and performance Bond as a public servant for Ontario Works and the City of Ottawa
5. A copy of Your communications with MHI advising them of the Breach of Colleen's Trust, and the instructions provided to MHI by the City of Ottawa regarding the Breach (what did You do to contain the breach with MHI, who also received the information?)

By failing to respond, You also tacitly agree by Way of 'no contest' to the following assertions:

1. A Breach of Trust is a form of harm, and those who are harmed are entitled to compensation
2. Sean von Dehn and Colleen Lynch are entitled to compensation for Your Breach of their Trust

3. You agree to restore Benefits to Colleen Lynch promising never again to revoke those benefits so long as she is living, including utilities, other necessary home expenses, and an allowance for leisure and the pursuit of happiness
4. You Will do the same to compensate Sean von Dehn
5. You have destroyed **at least four documents** from Sean von Dehn's case file over **the last five years**, and destruction of personal, private property is a form of harm
6. Sean is entitled to compensation for the loss and destruction of his intellectual property
7. You Will apologize to Colleen and Sean for their inconvenience, and for taking so long to right Your trespasses against them
8. You Will pay The Kingdom of Heaven Found a Sean the sum of \$1,000,000.00 for additional undue hardship and duress if The Kingdom of Heaven Found a Sean is compelled to file these Notices legally and lawfully served upon You with a Court to compel performance in accordance with the Rule of Law and Your Fiduciary obligations to the intended Beneficiaries of the Public Trust
9. You, and all representative agents from the City of Ottawa responsible for causing harm to Sean von Dehn and continuing to trespass upon his inherent rights legally and lawfully protected in Canada over the last five years, Will be terminated and denied the right to ever be in a position of office which requires You to be bonded (for failing to Honour the terms and conditions binding upon You now, and for failing to Give Notice to Your insurer of the Claim against You for Breach of the Public Trust).

You acknowledge that if You fail to address any points in this email (which have been conveniently numbered for You), all uncontested points Will be presumed to be exactly that - uncontested assertions You do not dispute.

These Notices Will be filed with the Court as an Affidavit of Facts regarding this Matter, then with an Enforcement Office of the Court to enforce the Default Judgment against You.

You also recognize and understand that as a representative of the City of Ottawa, **You speak for the City of Ottawa**. Notice to Agent is Notice to Principal, Notice to Principal is Notice to Agent. You (the City of Ottawa) are hereby legally and lawfully served this **Final Notice**.

This is Your **FINAL NOTICE** before **DEFAULT JUDGMENT** is awarded against You tomorrow, August 19th at 5:00 PM.

Please also be advised, You may be sued in Your *private capacity*, and the City of Ottawa's attorney's Will not be at Your disposal. You Will not be permitted to use Public Trust money to defend against **violations of Your Oath**, as You are no longer *legally* a representative of the City when in violation of Your oath. You are legally and lawfully presumed to have abdicated Your position of office when abdicating demands for Your oath and performance bond to the Public Trust. Without a Bond, You are a treasonous traitor holding an illegitimate and unlawful position of office.
