Good afternoon Mr. Von Dehn,

This email is in response to the email you sent me last Friday Oct 7<sup>th</sup> and Sunday Oct 9th, 2022.

In your first email, you addressed that an updated special diet form signed by a medical professional was not required because you had already provided one in the past. After looking at your file and speaking to your current case worker, Tatiana Lindstrom, it was determined that the special diet form that you provided in 2020, the medical professional portion, was completed and signed by you on April 1, 2020; therefore, not sufficient or acceptable. It would be best if you considered getting the document I sent to you by mail, including the form for transportation benefits, completed by a medical professional as soon as possible to avoid any delay or impact on this benefit.

The second email, a response to my email, was sent as insults and threats to me for addressing you by your legal name in correspondence. I am reminding you of the *Public Conduct Policy and Corporate Trespass to Property Procedures/City of Ottawa*. Insults, threats, lengthy and endless emails every few days and expecting immediate responses, and refusal to accept or follow the instructions provided to your request follow under this policy and are deemed unacceptable behaviour. In addition, you use hostile, abusive, and offensive language in your correspondence; this will no longer be tolerated.

While you are welcome to raise your concerns, I must insist that you do so courteously and we will only respond to a new complaint, correspondence that contains factual information and does not contain insults and personal attacks.

Please note that the special diet benefit is suspended pending a completed and signed original copy by a medical professional.

## NOTICE OF BREACH OF TRUST, WILLFUL TRESPASS UPON CHARTER AND TREATY OBLIGATIONS

Dear Mr. Lili Mukalay,

For the hundredth time, I DO NOT HAVE A LEGAL NAME, 'Mr. von Dehn'. That is a position of public office (legally and lawfully) that an individual ELECTS to hold. No One may be compelled to hold a position of office under threat of economic hardship.

You continue to address Me as 'Mr. von Dehn' after You have been advised countless times that I find it more offensive than 'bitch, bastard, slave, degenerate' or similar insults to My Honourable Character. So I Will address You as 'MR. Lili Mukalay' because apparently, how You Self Identify is irrelevant to how I must address You, right?

Also, a Notice of Liability for Breach of Trust and advising You that Willful trespass upon My inherent rights legally protected by Canada's Treaty obligations is a criminal Act because it is done with intent to cause harm. You address Me as 'Mr. von Dehn' to intentionally antagonize and offend Me. I WILL NOT TOLERATE Your contempt for the Rule of Law and Your Fiduciary obligation to Act in the BEST INTEREST of the Beneficiaries You were Trusted to care for by the Ontario Works Act. The Act was not designed to empower You to use threat of economic harm to trespass upon My rights, it was Created to ensure I have sufficient economic wealth to enjoy My rights.

You were Given a copy of My Trust instrument which is legally and lawfully binding, along with a comprehensive, detailed Declaration of the Trust simple enough for a five year old to understand, yet You continue to 'pretend' You are too stupid or incompetent to comprehend the law as I write it out for You? Once again, here is the Treaty on International Civil and Political Rights, **legally and lawfully binding upon all service agents of Canada's government in any capacity.**

### ***The Treaty, it's Ratification and Status in Canada***

Here are parts 1 and 2 of the Act, for the hundredth time...

# Article 1

1. All peoples have the right of self-determination. By virtue of that right they freely determine their political status and freely pursue their economic, social and cultural development.

2. All peoples may, for their own ends, freely dispose of their natural wealth and resources without prejudice to any obligations arising out of international economic co-operation, based upon the principle of mutual benefit, and international law. In no case may a people be deprived of its own means of subsistence.

I look forward to hearing why You believe You are above the Law and not subject to federal and international law.

Please be advised that a Notice of Liability is the first DUE PROCESS of law in any common law jurisdiction. Any legal argument not legally or lawfully rebutted, is presumed to be agreed as fact by both parties. If You cannot provide for Me an exemption clause for Ontario Works from Canada's Charter and International Treaty obligations, You are guilty of Breach of Trust with Criminal Intent.

I look forward to discussing Your beliefs with You in a Court of competent, concurrent Jurisdiction.

The package that was sent to You with documents for MHI were also send On Her Majesty's Service and You were asked to keep a copy of the envelope on My Record as evidence of My Sworn Oath to God and the Queen. You are now trespassing upon a Man who has sworn an Oath to the Crown which is an Act of Treason, interfering with My determination to protect the inherent (Charter and Treaty) rights of Canada's People.

Your gross contempt for the Rule of Law is unconscionable. I look forward to having a day in Court with You, and I Will take Your job. It is not a threat, it is a Promise because You are committing a criminal Act by Willfully trespassing upon My treaty

And further to Your legal obligations, if there is nothing in the Ontario Works Act to provide for My inherent rights legally protected by a Treaty obligation...

## Article 2

1. Each State Party to the present Covenant ***undertakes to respect and to ensure to all individuals within its territory and subject to its jurisdiction the rights recognized in the present Covenant, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.***

2. ***Where not already provided for by existing legislative or other measures, each State Party to the present Covenant undertakes to take the necessary steps, in accordance with its constitutional processes and with the provisions of the present Covenant, to adopt such laws or other measures as may be necessary to give effect to the rights recognized in the present Covenant.***

So if You don't have a means for Me to freely dispose of My natural wealth, then You have an obligation to Create a means for Me to do so.

The Ontario Works Act does not absolve You from other laws in Canada.
