Dear Antoine,

This 'Decision' is an abomination upon the Rule of Law and Canada's Justice system, and a 'colossal attack' on the Trustee and Claimant, 'The Kingdom of Heaven Found a Sean'. It appears Jaye Hooper does not understand the Rules of the Court which are binding upon her Oath. A Man has the presumption of innocence against any attacks upon his Character until proved guilty in a public trial by a jury of his or her peers. If Justice Jaye Hooper Wishes to attack the Beneficiary of the Trust, 'Sean von Dehn', she Will be required to prove her allegations against him. King Sean, of House von Dehn requires the Judge to provide proof of service of the Casullo endorsement, and the Court of Record for the Estate application which has not been filed with the Court to this day!!!

The entire testimony made by defense counsel is a testimony of fraud and perjury on a Court of Record with malicious intent to defame the Character of the Trustee and the nature of the Trust's Claim.

The Justice doesn't even appear to know how to properly Style a document in the Common Law. This is a Trust Claim, and if the Judge requires examples, she had the Gomery Endorsement to reference, which acknowledges that this is a **Trust Claim**, and that the Trustee, King Sean, of House von Dehn, believes his brother and sister have 'colluded' against him to deprive him of his rightful share of Estate assets, and were negligent in their duty of care to Sean as the primary beneficiary. This Court is not going to abdicate its obligations by gas lighting the Trustee and pretending they don't know what a Trust is, or that a Court of Equity is required.

This is the official response from King Sean of House von Dehn for the Kingdom of Heaven Found a Sean. Sean von Dehn did not bring a claim before this Court, the artificial person created in the Man's name is a beneficiary of the public Trust which Justice Jaye Hooper has effectively breached, and it is that person for whom Sean is Acting as Trustee for the (artificial) person's Benefit.

Fraud and perjury are not admissible on a Court of Record, nor is a Man presumed to be guilty until he has had fair and reasonable opportunity to defend him Self against false allegations. No One Will make such ludicrous, false, defamatory statement regarding the Character of a Beneficiary of the Trust without being required to provide proof (evidence) of their allegations against him. This is inconsistent with the very principles of Justice these Superior Courts were Trusted to protect.

To threaten a Claimant with harm for exercising his right to a public hearing while ignoring the Claimant's complaint of fraud and perjury in an Estate application, shows extreme bias, prejudice, and I dare say bigotry. This is unacceptable, unprofessional conduct unbecoming of a Justice, and fraud and perjury nullify any Court ruling. This decision is hereby void until the Justice provides proof of her allegations against the Beneficiary of the public Trust, Sean von Dehn. Please also be advised that failure to do so Will be perceived as an admission of wrongdoing, and the Justice Will be liable to the Claimant. Sean von Dehn has demanded \$100,000. in punitive damages be awarded against any Man who accuses the Claim of being a 'colossal attack' on an Endorsement the Claimant had no knowledge of prior to filing the claim and receiving the information in Hala's Statement of Defense. These are the FACTS on this Court of Record.

I also require to know how long I should expect to wait for the Judge to respond to the Motion of Contempt for opposing counsel's fraudulent testimony to the Court, it is patently unreasonable, bias and prejudice for any officer of the Court to ignore a Motion made to the Court by One party while hearing Motions filed by their opposing counsel. A judge should NEVER be threatening a Man with harm for exercising his rights in accordance with Canada's Charter in ANY Court of Law in Canada that presumes to be legitimate.
