I'm curious to know how the police were able to verify that the Man arrested is the same Man responsible for the theft of Christmas presents from the back of a car, and how he could possibly be facing 54 counts contrary to the criminal code for a single act. Is he being charged with one count of theft for every gift or gift card - it seems a little excessive for a non-violent crime?

I'm interested to know because I would like to know if the Man has legal representation, whether he is in jail or was released on a promise to appear or bail. I may be interested in providing him with free legal counsel to defend against these charges if he is not able to afford a lawyer and/or does not qualify for legal aid.
