Still no Court of Record for any Estate filed in Bracebridge for the Estate of 'von Dehn', 'vondehn', or 'CV-20-59'. I have included the search results for Your convenience. Why have the documents not been filed with and processed by the Court?

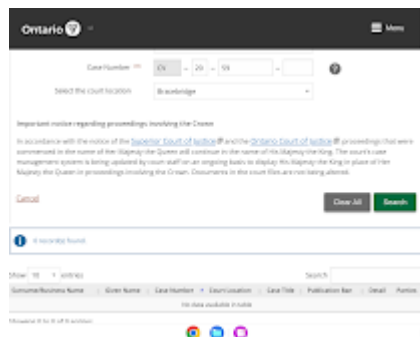

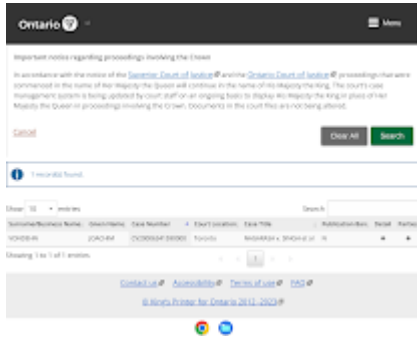
