Registrar Colluding in Estate Fraud

Dear Honourable David Lametti,

I regret to inform You that a Registrar of one of the Courthouses under Your watch, Michelle Murphy, has colluded with a lawyer (Hala Tabl) to receive documents for an Estate Application and NOT file them onto the Court of Record, and to tell all other interested parties to the Application that the Application is not being processed because of 'covid delays'. When I learn this is not True and that an Endorsement has been made against Me without My knowledge or opportunity to attend the hearing, I once again email the Bracebridge Courthouse and ask for a copy of the Court of Record so that I can see with My own eyes the Endorsement that was awarded against Me - Michelle Murphy tells Me that I am not able to receive a copy of the Endorsement against Me, or able to know any other information regarding My father's Estate Application (CAET) because the Estate is 'not open to the public' and Will not be open to the public until 'after a Certificate Issues'.

I have been deprived of My right to a fair and public hearing regarding the appointment of Estate Trustee for My father's Estate because of a Registrar of one of Your Courts. I have placed Michelle Murphy on Notice of Civil and Criminal Liability, her actions are an indictable offence according to Canada's Criminal Code, 380.1 - the fraud does involve a testamentary instrument regarding property valued over \$5000.00 (roughly half a million).

Needless to say, I have been seriously harmed by Michelle's criminal conduct and negligence, and am as King for relief and remedy as soon as possible. I am not sure if private criminal prosecution is the correct route to go, I am letting You know about this first in hopes that You can put an end to the harm being done to Me (this is ongoing, My sister currently has a fraudulent Certificate as no due process has been had). I've also been accused of 'attacking' the judicial process and the 'Casullo Endorsement' against Me, when Michelle Murphy knows first hand that I had no knowledge of anything taking place regarding My father's Estate including the Endorsement awarded against Me because Michelle Murphy was refusing to share the information with Me. I filed a claim against the Estate because 'covid delays' was becoming a mundane excuse and I ran out of patience.

The Bracebridge Courthouse does not respond to My emails, and I've just requested Motion dates for the Barrie Courthouse so I can file a Motion under Rule 75.01, 75.03, 75.04, 75.05, for the return of the fraudulent certificate, and also for a Motion of Contempt (Form 31). I made the request for available dates yesterday, still haven't heard back. This concerns Me because I'm not sure how many officers of the Court may be involved in the fraud.

Can You please look into this, I require for the fraud perpetrated by officers of Your court to stop, and for an Honourable Justice to consider the evidence as soon as possible. I Wish for criminal prosecution. I presume that officers of the Court are required to be bonded for performance in accordance with the Rule of Law and the Rules of the Court?
