Dear Sir or Madam,

I have indicated that a response to this email is REQUIRED. Is there any reason as to why You would be REFUSING to Honour a FOIA request? I am ENTITLED to full disclosure of all Matters concerning My interests. Dear Jenny,

NO, I am NOT required to fill out a freedom of information request form OR pay \$5.00 to receive disclosure of the Estate Application filed with but NOT processed by Your Court. I am as King as My RIGHT to FULL DISCLOSURE of all LEGAL and LAWFUL Matters concerning My interests.

This Court is OBLIGED to provide Me with full disclosure of all Matters concerning My interests.
