Good morning,

I am the primary Beneficiary in the above listed Estate Application filed with Your Court (but NOT yet processed by Michelle Murphy from what I understand), though allegedly a Certificate has been issued WITHOUT any of the documents being processed or entered onto the Court of Record in violation of the Rules of Civil Procedure, the Rule of Law, and My right to a public hearing where I am entitled to full disclosure of all documents concerning My interests.
