Thank you for your emails dated April 17 2023, sent to the Ministry of Attorney General Webmaster. Your emails have been shared with our office for response.

Please note that your emails do not constitute notice of a claim for damages as required under the [Crown Liability and Proceedings Act, 2019](#), which governs proceedings in Ontario against the Crown. Information about serving documents on the Crown in a civil case in Ontario is available on the Ministry's [website](#).

We hope you will understand that Ministry staff and officials cannot provide legal advice, interfere in private legal matters, or comment on judicial decisions. Judicial independence is a fundamental part of our justice system, and judicial officials must be free to make decisions without influence from external parties such as government staff or elected representatives. Judges are accountable for their decisions through the appeal process and for their conduct through judicial complaint procedures. A lawyer can assist you in reviewing the available and appropriate options in this regard.

With respect to your comments about judges of the Superior Court of Justice, please note that the [Canadian Judicial Council](#) has the sole authority to review the conduct of federally appointed judges.

Your comments with respect to court staff have been shared with local court management for consideration. We understand that the Barrie and Bracebridge Courthouses provided you with responses dated May 3, 2023 with respect to your comments.

To whom this may concern,

This email is unacceptable and cannot be legally or lawfully accepted as there is no officer of the Crown accepting accountability for this information. I require a response to My very clear questions regarding the incompetence of these CROWN courts which are to be of inherent, **concurrent, congruent** jurisdiction. If due process has been had in any Estate application for a Certificate of Appointment of Estate Trustee, You Will have a RECORD of those proceedings where proof of service of all hearings regarding all Matters upon all parties with an interest in the outcome of the proceedings.

NO COURT in Ontario seems to be able to provide Me with a valid CV number for the Estate Application of Joachim Heinrich von Dehn, there is no public Court of Record for this file, yet a certificate was allegedly issued unlawfully by the Bracebridge Courthouse who is now REFUSING to respond to emails to explain why a Court registrar has been colluding with My sister's lawyer with criminal intent to exclude Me from My right to participate in the proceedings.

These COURTS (the Crown) and its elected representatives, have now ACCUSED the Trust's Claim (The Kingdom of Heaven Found a Sean) as being a 'colossal attack on the Casullo Endorsement'. The Ottawa Court also determined that due process was had in the Estate Application, and that 'Sean von Dehn', the primary beneficiary, had sufficient time and opportunity to appeal the Casullo Endorsement, which has long since expired.

Considering it is officers of these Courts making these accusations against the Trust and its Trustee, King Sean of House von Dehn, I am as King under My right of full disclosure regarding all Matters concerning My interests that proof of service of the Casullo hearing and proof of service of the Casullo Endorsement upon Sean von Dehn be provided to Me immediately as per My right of full disclosure.

If You cannot provide proof of service of the Casullo Endorsement upon Sean Stephen von Dehn for the Estate Application of Jaochim Heinrich von Dehn, this Court is guilty of fraud and breach of Trust. Managers of these respective Courts are not responding to emails regarding these queries, which is criminal interference in justice perpetrated by agents of Your Courts.

Again, these Courts have demonstrated such contempt for the Rule of Law, the Rules of Civil Procedure and gross incompetence in the administration of justice in violation of their oath to these Courts, that I WILL NOT be providing any addition time than the sixty days notice already provided to David Lametti, Canada's Minister of Justice and Attorney General. If David Lametti Wishes to pretend that he can't hear Me or that he didn't receive the sixty days notice, I DO NOT CARE - I Will Show His Majesty, King Charles III, the David Lametti was made aware of these crimes more than sixty days before the Claim was brought against his Majesty for the negligence and contempt of officers presuming to represent the Crown.

I look forward to hearing from You and receiving a copy of the Application Record filed with the Court for the Estate Application of Joachim Heinrich von Dehn which Will require proof of service of all motion for directions and all endorsements on all parties to the proceeding before the application can be legally or lawfully processed by the Court - so I am sure You Will have no problem producing it.
