PLEASE TAKE NOTICE:**ALL RECIPIENTS OF THIS EMAIL ARE HEREBY PLACED ON NOTICE OF BREACH OF TRUST, ABDICATION OF OATH, AND GROSS CRIMINAL NEGLIGENCE CAUSING HARM**

To bring a Matter before a Tribunal and advise the Tribunal that the requirement to seek medical care is a violation of the Trust Instrument, and for the Tribunal to determine that it is in ANY WAY acceptable to IGNORE a Trust Instrument on file with Ontario Works since July of 2017, and that Public Trustees have been ignoring and spoliating documents to plead ignorance of the Trust on file with their office, is GROSS INCOMPETENCE AND CRIMINAL NEGLIGENCE.

Undisputed, criminal Acts were reported on the Court of Record before this Tribunal today, and Brian Killick seems to think it is perfectly reasonable and acceptable to allow the breaches of Trust and trespass upon a testamentary instrument in violation of the Trustee Act of Ontario, an indictable, criminal offence subject to no longer than fourteen years in jail, and to DO NOTHING TO PUT A STOP TO THE HARM OR TRESPASSES, ASSERTING THE ONTARIO WORKS ACT HAS THE FORCE OF LAW TO TRESPASS UPON THE TRUST, THE TRUSTEE ACT OF ONTARIO, ONTARIO'S HUMAN RIGHTS CODE, AND DONE WITH **INTENT TO CAUSE AS MUCH ECONOMIC, EMOTIONAL, AND PSYCHOLOGICAL HARM AS POSSIBLE**, is contrary to the very purpose of these Tribunals.

The point of a Tribunal is not to plead ignorance of the rights violations because 'it's not the rights violation hearing today, so the trespasses upon Your Trust may continue until then', is absolutely unacceptable. If Brian Killick does not advise Ontario Works that the judgment awarded against them is binding, Brian Killick Will be fully liable in his personal, private capacity, because he is not entitled to the protection of his insurance when in breach of his oath to the Court, the Rule of Law, and his duties and obligations as public Trustee.

You are all hereby Given Notice, and Your position Will be taken into consideration for aggravated circumstances at the time of sentencing. You Will all (eventually) be held accountable, You can only gaslight and stall the rights violation for so long.

I am including the recording of today's proceeding as evidence of Your contempt for the Rule of Law and Canada's Criminal Code. I Will be adding this recording as evidence for this Claim related to the rights violation, and as King of You to be named as a co-conspirator of the fraud and trespass upon the Trustee Act of Ontario and My Trust obligate-Sean's.
