Further to the below correspondence, I can confirm the following, in order, as you requested:




1. The balance of the funds owing pursuant to the decision of the Tribunal were issued on November 7, 2023, which explains why they may have only arrived in your account on the following day. The amount of \$1,239 reflected the following:
 - a. The SBT decision noted that you were entitled the Special Diet Allowance for January and February 2023 at the rate of \$191.00 per month or a total of \$382.00.
 - i. We issued \$1,000, calculated at \$250/month (instead of \$191.00) for not only January and February 2023, but also the preceding November and December of 2022, as agreed to prior to the hearing.
 - ii. This means you received \$236 in additional funding not contemplated in the Tribunal's decision.
 - b. The SBT decision also found that you were entitled to the Medical Travel and Transportation benefits from January 2023 onwards at a rate of \$119.50 until, if any, a decision is issued by the Administrator. The decision calculated this to be \$1,195 from January 2023 to October 2023 (10 months).
 - i. We issued \$239 for January and February 2023 on November 7, 2023;
 - ii. The payments for March 2023 to November 2023, totaling \$1,129.50 were already being issued on a monthly basis from March 22, 2023 (to cover March 2023) to October 31, 2023.
2. Attached are the screen prints showing the payments described above.
3. No action is being taken regarding your previous emails referencing defaults judgments. We do not have original copies of your judgment and so nothing will be returned.
4. We do not recognize, nor can we rely on your Trust Instrument for the purpose of administering your Ontario Works benefits.
5. We have met the requirements of the order and consider this matter closed.

This is incorrect.

The travel allowance was revoked for the months of November and December of 2022 and *not included in the amount You conceded to owing Me*. These are the funds that are missing from the Tribunals ORDER.

You say You deposited \$239.00 into the account for transportation for January and February 2023, but You HAVE NOT reimbursed the months of November and December's travel allowance, which is another \$239.00.

The medical benefits were revoked for FIVE months, not four. October, November, December, January and February. The CORRECT medical benefits I'm ENTITLED to, are \$250/month according to the medical record You have on file. All it proves is that You were shorting Me the medical benefits I was previously entitled to, and to the tune of \$58.50/month.

You were ORDERED to pay out \$1577.00 and You took it upon Your Self to pay whatever YOU feel is correct without any discussion with Me, without any receipt or even Notice that the funds were deposited to the account? I am ENTITLED to a receipt for the payments, and You are required by Law to provide them upon request.

YOU HAVE NOT MET THE ORDER OF THE TRIBUNAL!!! THAT STATEMENT IS FRAUD!!! YOU PAID WHAT YOU FEEL YOU WISH TO PAY, NOT WHAT WAS ORDERED BY THE TRIBUNAL. YOUR TIME TO MAKE THESE ARGUMENTS EXPIRED WHEN THE HEARING ENDED!!!

You owe Me the amount ordered by the Tribunal unless You Wish to appeal the decision, You do NOT have any right to change it. You are WRONG, and still shorting Me at least the \$229.00 for the months of November and December 2022 for travel allowance.

"We do not recognize, nor can we rely on your Trust Instrument for the purpose of administering your Ontario Works benefits."

Really? Can some One at Your office explain to Me why the Trustee Act of Ontario would apply to all Trusts whenever Created and all Trustees whenever appointed EXCEPT Sean von Dehn's Express Trust in God on file with Canada's Minister of Justice and Attorney General?

What other steps do I need to take OTHER than filing My Trust Instrument with Canada's Minister of Justice and Attorney General before the Trustee Act of Ontario applies to My Trust on file with Your office?

If You don't have the default Judgment, You are liable to Me for the full value of My intellectual property, which is \$100,000.000.00.

What are You going to do to compensate Me for the vandalism of My Trust Instrument?

I do NOT Wish to be subject to a Trustee like Nana Asante who is going to trespass upon My Trust Instrument.

Please tell Me why the Trustee Act of Ontario does not apply to You, Me, or any other agent at Ontario Works, apparently? And how is suggesting it doesn't not a rights violation if it applies to every other Trust in the province of Ontario?

You, Caroline Forget, are hereby on Notice for conspiring to trespass upon a Trust Instrument and for suggesting the Trustee Act of Ontario is not binding upon the Public Trustee. You are a fraud.
