I am acting as Trustee and Executor for the Estate of Joachim Heinrich von Dehn in accordance with a private family Trust, 'The Kingdom of Heaven Found a Sean'.

Tanja Johnson has been awarded a Certificate of Appointment of Estate Trustee for Joachim VONDEHN to represent My father in Court but she does not appear to be doing so and I can't find any Record of her Application on the Registry or the Appointment of the Certificate having been Issued.

Greg McConnell Claims Tiffany Singh, joint defendant with Joachim VONDEHN in the Claims waiting to proceed against the Estate, and states that he has a Holograph Will for Tiffany Singh naming her as the Trustee and Executor. I also have included the contact information for the lawyers of the 'Beneficiaries' claiming to have shares on the remainder funds without addressing these claims. I'm not a lawyer, just a Trustee of a private, family Trust but I thought this inform a Sean Will be useful for the creditors waiting to proceed with their Claims. My father has Trusted Me to ensure that all his creditors were made whole, and I would like to Honour this Fiduciary obligate-Sean.

I look forward to addressing these Claims on My father's behalf, and would also like to invite the creditors to attend Court in Ottawa on October 23rd (this coming Monday) at 10:00 AM where they Will have an opportunity to confront the debtors directly. I Will be as King for criminal prosecution against all the accused, as well as two court clerks not named in the attached notices from the Bracebridge Courthouse who were colluding with these lawyers to keep documents private without posting to the Registry (Michelle Murphy and Carey Thompson).
